



#### **ORGANIZATION OF ARAB PETROLEUM EXPORTING COUNTRIES (OAPEC)**



The Organization of Arab Petroleum Exporting Countries (OAPEC) was founded on the basis of the agreement signed in Beirut, Lebanon on 9 January 1968 between the governments of Kingdom of Saudi Arabia, the State of Kuwait and the (then) Kingdom of Libya. The agreement stipulates that the Organization shall be domiciled in the City of Kuwait.

The principal objective of the Organization is the cooperation of the members in various forms of economic activity in the petroleum industry, the determination of ways and means of safeguarding the legitimate interests of its member countries in this industry, individually and collectively, the unification of efforts to ensure the flow of petroleum to its markets on equitable and reasonable terms, and providing appropriate environment for investment in the petroleum industry in member countries.

In 1970 the United Arab Emirates, the State of Oatar, the Kingdom of Bahrain and the Republic of Algeria joined the Organization, followed by the Syrian Arab Republic and the Republic of Iraq in 1972, Arab Republic of Egypt in 1973, then the Republic of Tunisia in 1982 (its membership was suspended in 1986). Any Arab country which derives a significant share of its national income from petroleum is eligible for membership in OAPEC upon the approval of three-quarters of the member countries, including all three founding members.

#### • OAPEC-Joint Ventures:

OAPEC has sponsored the creation of four companies: The Arab Maritime Petroleum Transport Company (AMPTC), established in 1972 with headquarters in Kuwait City, the Arab Shipbuilding and Repair Yard Company (ASRY) established in 1973 with headquarters in Bahrain, the Arab Petroleum Investments Corporation (APICORP) established in 1974 with headquarters in Khobar, Saudi Arabia, the Arab Petroleum Services Company (APSC) established in 1975 with headquarters in Tripoli, Libya.

#### **OAPEC'S ORGANS**

- The Organization carries out its activities through its four organs:
- Ministerial Council: The Ministerial Council is the supreme authority of the Organization, responsible for drawing
  up its general policy.
- Executive Bureau: The Executive Bureau is composed of one representative from each of the member countries, drawing recommendations and suggestions to the Council, reviewing the Organization's draft annual budget and submitting it to the Council, it also adopts the regulations applicable to the staff of the General Secretariat. The resolutions of the Executive Bureau are issued by the majority of two- thirds of all members.
- General Secretariat: The General Secretariat of OAPEC plans, administers, and executes the Organization's activities in accordance with the objectives stated in the agreement and directives of the Ministerial Council. The General Secretariat is headed by the Secretary General. The Secretary General is appointed by resolution of the Ministerial Council for a tenor of three years renewable for similar period(s). The Secretary General is appointed by resolution official spokesman and legal representative of the Organization and is accountable to the Council. The Secretary General directs the Secretariat and supervises all aspects of its activities, and is responsible for the tasks and duties as directed by the Ministerial Council. The Secretary General and all personnel of the Secretariat carry out their duties in full independence and in the common interests of the Organization member countries. The Secretary General and the Assistant Secretaries General possess in the territories of the Organization members all diplomatic immunities and privileges.
- Judicial Tribunal: The protocol of the Judicial Tribunal was signed in Kuwait on 9 May 1978 and came into effect on 20 April 1980. The Tribunal is competent to consider all disputes related to the interpretation and application of OAPEC's establishment agreement, as well as disputes arising between two or more member countries concerning petroleum operations.



# **54** YEARS ON... **OAPEC** SAILS TOWARDS THE FUTURE WITH A NEW SPIRIT

OAPEC joint ventures include: Arab Maritime Petroleum Transport Company (AMPTC) established in 1972 (headquartered in Kuwait City, Kuwait); Arab Shipbuilding and Repair Yard Company (ASRY) established in 1973 (headquartered in Manama, Bahrain); Arab Petroleum Investments Corporation (APICORP) established in 1974 (headquartered in Al Khobar, KSA); Arab Petroleum Services Company (APSCO) established in 1975 (headquartered in Tripoli, Libya); in addition to the Arab Petroleum Training Institute (APTI) established in 1978 (headquartered in Baghdad, Iraq). These JVs have contributed actively in boosting the progress of the Arab petroleum industry through executing and funding joint or individual projects in many OAPEC and non-OAPEC Arab countries.

international level. OAPEC On has been working on strengthening its ties with numerous regional and international organisations specialized in energy and economy. This is in order to make its member countries' stances clear in terms of current developments and future prospects relevant to the energy industry, especially petroleum. The Organisation also follows up closely current global petroleum developments to observe their potential impacts on the economies of its member countries. This is done through conducting technical and economic studies covering petroleum and gas industries (about 10 studies per year). OAPEC is also keen on monitoring UNFCCC and Kyoto Protocol developments, upon the directives of OAPEC Council of Ministers, in order to explain the member countries' stances on these issues. This is done in coordination with the Arab Negotiating Group, the Arab League, and OPEC, as coordinating meetings take place to discuss draft resolutions and issues under negotiation to ensure no resolutions with negative impact on the member countries' economies are made by the Conference of the Parties (COP).

On another note, OAPEC's endeavours to serve the petroleum industry have always been a matter of global appreciation throughput its long journey. Most recently, OAPEC won a prestigious award presented by Standard & Poor's Global Platts Agency for the year 2021 (S&P Global Platts), at the 23rd Annual S&P Global Platts Global Energy Awards, often described as the "Oscars" of energy.

Moreover, the Arab Shipbuilding and Repair Yard Company (ASRY), an OAPEC joint venture, has won the Shipbuilding and Ship Repair Award at the prestigious Seatrade Maritime Awards MEISA (Middle East, Indian Sub-continent & Africa) 2021 ceremony, held in December 2021 in Dubai, UAE.

# INTRODUCTORY MEETING ON JOINT ARAB ECONOMIC REPORT 2022



OAPEC Secretariat General took part in the introductory meeting discussing the Joint Arab Economic Report 2022, held at the Arab League Headquarters, from 20 to 22 December 2021. Representatives from the Arab League Secretariat General, the Arab Monetary Fund, and the Arab Fund for Economic and Social Development took part in the meeting. Mr. Majed Amer, Senior Economist from the Economic Department, represented OAPEC Secretariat General at the meeting.

During the meeting, the contents of the 2022 report chapters have been discussed and their structures were approved. OAPEC Secretariat General prepares Chapter 5 on energy developments (covering Arab and world exploration and reserves; energy demand; world oil inventories (commercial and strategic); oil and gas exports; Arab oil exports value and their implications for Arab economies). OAPEC also prepares the section on hydrocarbon industries in chapter 4 covering the industrial sector.

The conveners underscored the importance of continuing developing the report contents due to its growing importance as a reference in high demand by researchers and interested institutions and individuals. It has been agreed that the pivotal chapter of the 2022 report will focus on "Environment & Climate Change in the Arab Countries: Current Status & Future Prospects."

# SPECIAL MEETING OF THE OPEC CONFERENCE APPOINTS KUWAIT'S AL GHAIS AS NEXT SECRETARY GENERAL



A Special Meeting of the Conference of the Organization of the Petroleum Exporting Countries (OPEC) was held via videoconference on Monday, 3 January 2022, under the Chairmanship of its President, HE Bruno Jean-Richard Itoua, Congo's Minister of Hydrocarbons and Head of its Delegation.

In accordance with Article 28 of the OPEC Statute and in application of the procedure decided at the 182nd Meeting of the Conference on 1 December 2021, the Conference decided by acclamation to appoint Mr Haitham Al Ghais of Kuwait as Secretary General of the Organization, with effect from 1 August 2022, for a period of

Mr Al Ghais, a veteran of the Kuwait Petroleum Corporation (KPC) and Kuwait's OPEC Governor from 2017 to June 2021, currently serves as Deputy Managing Director for International Marketing at KPC. He Chaired the Joint Technical Committee (JTC) of the Declaration of Cooperation (DoC) in 2017 and subsequently served as a Member of the JTC until June 2021.

In its decision, the Conference expressed its appreciation to HE Mohammad Sanusi Barkindo for his leadership during his twoterm tenure as Secretary General beginning on 1 August 2016 and ending on 31 July 2022.

### Monthly Report on Petroleum Developments in The World Markets

#### Monthly Report on Petroleum Developments In The World Markets January 2022

#### **First:** World Oil Markets

#### 1. Oil Prices

OPEC primary estimates indicate that OPEC Reference Basket price increased in January 2022 by 12.4% compared to the previous month, to reach \$83.58/bbl. While annual price of OPEC Basket is estimated to increase in 2021 by 68.5% compared to 2020, to reach \$69.89/bbl.

It's worth mentioning that, OPEC Reference Basket decreased in December 2021 by 7.5% or \$6/bbl compared to the previous month, to reach \$74.4/bbl This is mainly attributed to a sharp decline in the futures markets amid concerns about record-high COVID-19 cases, including in several major oil-consuming countries. Nonetheless, the fundamentals of the physical crude oil market remained relatively robust.

#### 2. Supply and Demand

Primary estimates indicate that world oil demand is increased in Q4 2021 by 2.4% compared with previous quarter, to reach 99.8 million b/d. As demand in OECD countries increased by 0.9% to reach 46.1 million b/d. And demand in Non-OECD countries increased by 3.2% to reach 53.7 million b/d.





Projections indicate that world oil demand is expected to decrease in Q1 2022 to reach 99.1 million b/d. As Demand in OECD countries is expected to decrease to reach 44.6 million b/d. Whereas demand in Non-OECD countries is expected to increase to reach 54.5 million b/d.

- Primary estimates indicate that world crude oil and NGLs/condensates total supplies in December 2021, increased by 177 thousand b/d or 0.2% comparing with previous month level to reach 98.4 million b/d. Non-OPEC supplies increased by 0.02% to reach 65.4 million b/d, and OPEC supplies increased by 0.5% to reach 33 million b/d.
- OPEC+ crude oil total supplies in December 2021, is increased by 200 thousand b/d, or 0.5% comparing with previous month level to reach 38.2 million b/d. Non-OPEC supplies, which are members in OPEC+, increased by 0.5% to reach 13.9 million b/d. And OPEC-10 supplies, which are members in OPEC+, increased by 0.8% to reach 24.3 mb/d.
- US tight oil production increased slightly in December 2021 by 82 thousand b/d compared to previous month level to reach 8.344 million b/d. Production is expected to continue rising in January and February 2022 to reach 8.540 million b/d. On other development, US oil rig count increased in December 2021 by 25 rigs, to stand at 522 rigs.




#### US tight oil production and oil rig count

#### **3. Oil Inventories**

OECD commercial inventories in December 2021 decreased by 49 million barrels from the previous month level to reach 2707 million barrels, and strategic inventories decreased by 7 million barrels from the previous month level to reach 1789 million barrels.

#### 4. Oil Trade

#### **US Oil Imports and Exports**

- US crude oil imports in December 2021, decreased by 0.1% from the previous month level to reach about 6.3 million b/d, whereas US crude oil exports increased by 0.2% to reach about 3 million b/d.
- US petroleum products imports in December 2021 decreased by 3.3% from the previous month level to reach about 2 million b/d, and US petroleum products exports decreased by 5.6% to reach 5 million b/d.

#### Second: Natural Gas Market

#### 1. Prices

- The average spot price of natural gas at the Henry Hub decreased in December 2021 to reach \$3.76/million BTU.
- The price of Japanese LNG imports in November 2021 increased by \$2.6/m BTU to reach \$14.25/m BTU, the price of Korean LNG imports increased by \$2.52/m BTU to reach \$15.37/m BTU, and the price of Chinese LNG imports increased by \$4.83/m BTU to reach \$17.59/m BTU.

#### 2. Exports

Arab LNG exports to China, Japan and South Korea were about 3.553 million tons in November 2021 (a share of 21.4% of total imports).
